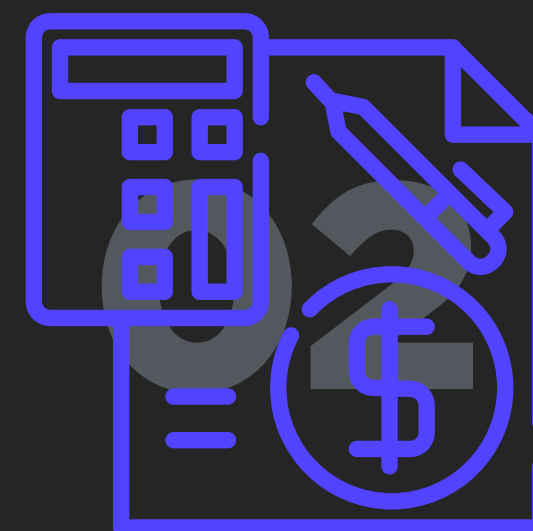

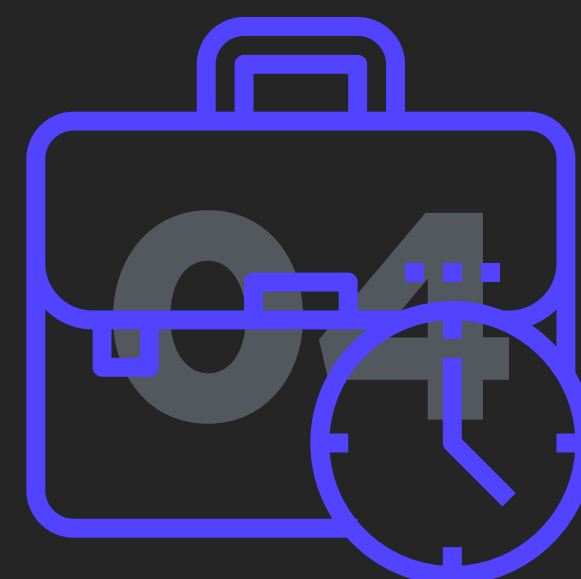
BPO

Incorporation services

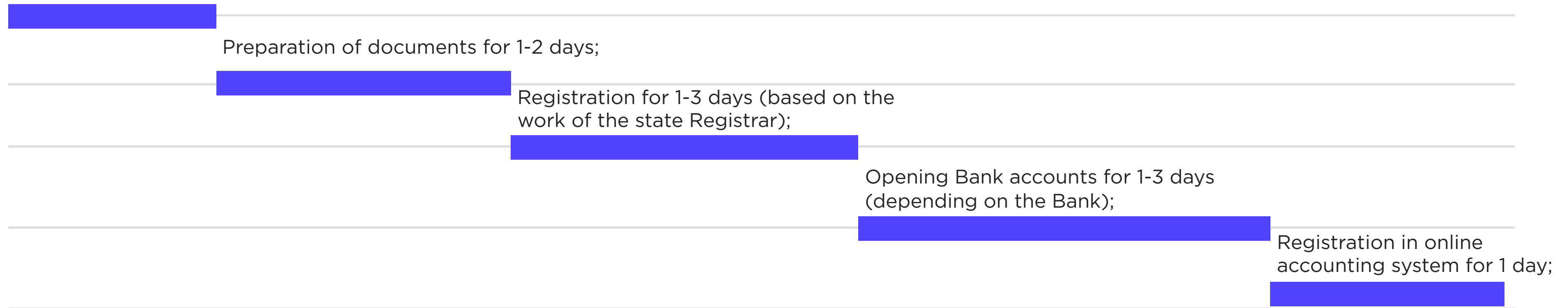
Alter helps in the creation and registration of business in Ukraine and abroad with the features of a future company. Conducts Due Diligence of the business.

Alter will prepare all the documents necessary for registration of company in Ukraine with the filing of required reports to State bodies. Open the necessary bank accounts considering your counterparties. If to foreign companies or investors are the issues of attracting foreign experts. Alter will receive for their residency in Ukraine. Before check business our company by tax planning choose the model of the taxation of the company and calculates future costs.



Registration of the company:

Tax planning work for 2-8 hours, depending on future operations of the company;



Total: 5-10 working days

After full procedure of company's registration you get: statute documents, bank account (s) and online accounting, stamp.



Residency:

Preparation of documents for 5-7 working days to receive the work permit;



Review and issuance of a work permit within 14 working days;



Preparation of package of documents for obtaining a residence for 3-5 working days;

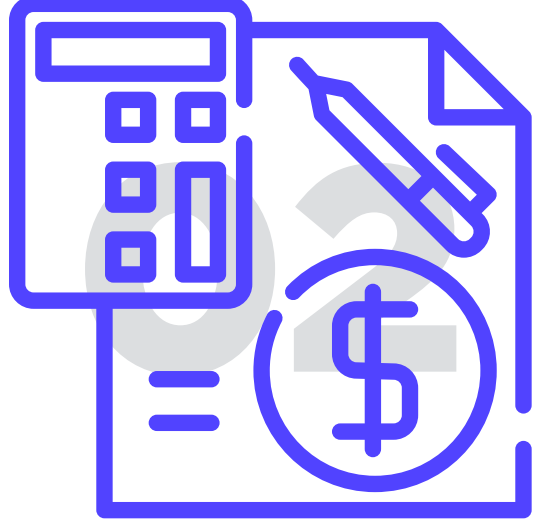


Filing of docs to obtain residency and the grant of a residence permit- up to 15 days (average 7 days);



Total: 29-41 working days

After full procedure of residency registration you get: one year residency.

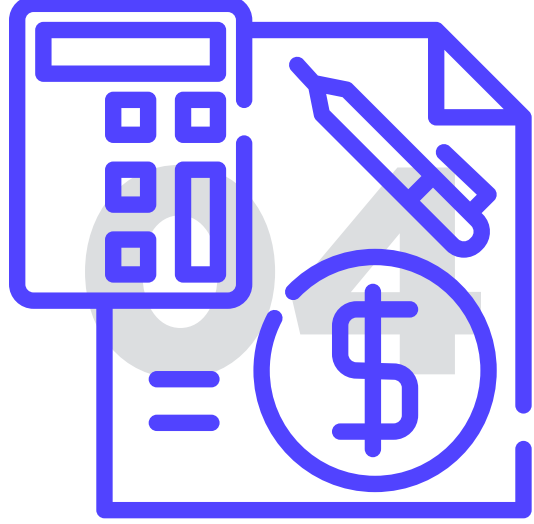


Legal-tech

Alter believes any problem is not problem, but a situation that needs to be resolved instantly. Advisers alter as the doctors find a way out by preventing.

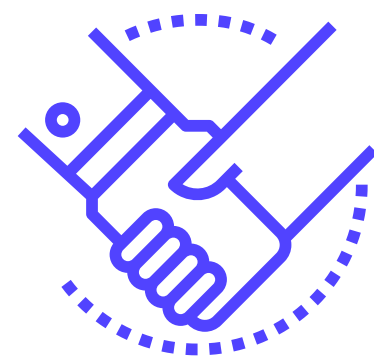
If the representative of the business situation of alter will help in two ways:

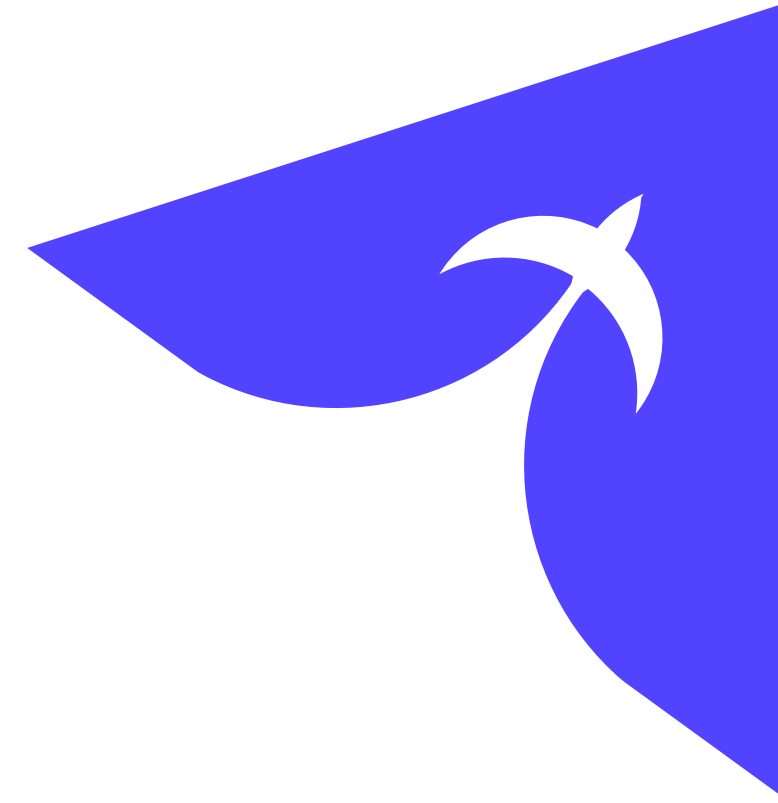
